

## **Step 1 - Honesty**

## Step 1: We admitted we were powerless over alcohol and our lives had become unmanageable.

In over 20 years of drinking, I never once entertained the possibility that I might be an alcoholic – despite overwhelming evidence that I was. I never drank moderately; I drank like a wet and dry shop vacuum from the start.

Then the two-week binge that got me into AA scared the hell out of me. The rate of progression accelerated. I found myself doing things I said I would never do --drinking in the mornings; missing work because of drinking. Worst of all, in the middle of that binge, alcohol stopped working for me -- it stopped killing the pain and it stopped taking me to oblivion. I was afraid that if I continued drinking I would go crazy and if I stopped I would fly apart. I was afraid that life as I had known it was about to end and it did. What I did not know is that was a good thing.

The precursor to Step One is Step Zero: This stuff has to stop. I had that one nailed down before I got here. I was sick of hangovers; sick of blackouts; sick of trying to explain things I could not remember; sick of inexplicable dents in my car; sick of trying to find the damn car for that matter; sick of fights with my ex- about my drinking; sick of the struggle to hide my drinking; sick of hiding bottles and forgetting where I put them; sick and tired of being sick and tired. Without that, I would never have gone to my first meeting. I aspired to be a member of the Farmington Country Club. I did not aspire to be a member of Alcoholics Anonymous. The first step is actually quite simple --

- Alcoholism is an insidious, incurable, progressive, killer disease and
- I have it.

The first half of step one, "We admitted we were powerless over alcohol" means there is no hope I will ever be able to control my drinking. For 20 years I tried to find a better strategy for managing my drinking. Today I know that thinking you need a strategy for your drinking is a sure sign of an alcoholic. Social drinkers do not need a strategy -- when they start to feel it they stop. I never thought like that. I never even wanted to think like that. Why would you want to stop when it was just getting good?

## Step 1 - Honesty (Continued)

Being powerless over alcohol means that I cannot safely drink. I believe that for me to start drinking again would set off a chain reaction in my life that would resemble a major train wreck. I believe that for me to drink would be to play Russian Roulette with only one empty chamber.

I had more trouble with the second half of the first step: "We admitted that our lives had become unmanageable." Do not tell me my life is unmanageable. I had been a professional manager for 15 years. The externals of my life looked great. I had a great job, a corner office, a 10-year-old relationship, a lovely home, a new car and two Pekinese who adored me.

And then it occurred to me that I had surrounded myself with non-alcoholic adult children who were doing for me things I should have done for myself. My spouse got me up, fed, dressed and headed for the office. My secretary told me when it was time to go to a meeting or go home. I had delegated everything to the people who worked for me and then I forgot who I gave it to. I would have foolish staff meetings where I would say things like "Could we have an update on this project?" I had no idea who was working on what. I just hoped somebody was.

I realized I was bankrupt -- spiritually, emotionally, physically, and mentally. I had chug-a-lugged myself into a deep hole that I could not get myself out of. Continuing to hang on as I had been was hopeless. So I decided to surrender.

- Minutes of the October Quarterly Meeting were reviewed.
  - o Linda moved to approve the minutes as revised. Harry seconded. Motion carried.

#### IV. FINANCIAL REPORTS:

- Linda (Financial Trustee) presented the October Financial Report.
  - Balance Sheet: Total CBIA funds as of October 31<sup>st</sup> totaled \$18,076.95
     ; \$50.00 in Petty Cash; \$4,146.19 in Checking; \$12,619.37 in Prudent Reserve and \$1,261.39 in the Jamboree Account.
  - Profit & Loss for the month of October: Group & Individual Contributions: \$2,870.81; Gross Sales (Books, Chips & Medallions): \$1,309.50 less Cost of Goods Sold \$889.22); Gross Gain for the month was \$3,291.09; Total Expenses were \$2,217.37 for a Net Gain of \$1,073.72 for the month.
- Linda and Rob discussed where we are with our revenue shortfall in 2020.
  - Net Revenue through the end of October is \$29,270.83 compared to Budget of \$33,574.92 (which was based on 2019 Actual Income); Donations were \$17,850.28 compared to Budget of \$15,737.9, Jamboree Revenue was \$7,500.00 compared to Budget of \$14,513.00. Social Event Revenue was \$1,901.00 compared to Budget of \$997.00; Social Event Expenses were \$20.70 compared to budget of \$1,100 (church halls were not rented) and Net Sales (after reduction for cost of goods sold) were \$1,938.25. compared to budget of \$3,427.00.
  - Expenses were \$28,789.68 compared to budget of \$30,660.21 (we have reduced hours and payroll by 25% beginning August 1<sup>st</sup>)
  - o Net Gain was \$481.15 compared with Budgeted Net Gain of \$2,914.71.
- Barb moved to approve the financial report. Judy seconded. Motion carried.

#### V. SERVICE AREA REPORTS:

- 12th Step Judy said we are working on an updated 12 Step List for January.
- Archives Gail said she is getting previously unorganized archival material into binders.
- Bilingual Enrique was not present.

## **CBIA Needs Ongoing Support**

## **Background**

#### **Jamboree**

Historically, the Coastal Bend Jamboree has provided 40% of CBIA income for the year (about \$15,000).

In 2020, the Jamboree was small due to competition from the S Padre Island Jamboree and the SE Texas Area Convention in Houston which were held the same weekend for the first time. Revenue was about half of previous years. Future CB Jamborees will be held in February to avoid this problem.

Restrictions necessary to avoid having the Jamboree be a super-spreader event have made it not economically viable to have a Jamboree in 2021.

### **Group Contributions**

In the past, CBIA's second biggest source of revenue has been Group Contributions. Since COVID-19 came to this area in March of 2020, some groups are not meeting at all, others are meeting only on Zoom; and the remaining groups are having smaller face-to-face meetings. Hence, **Group Contributions** total have been significantly reduced.

### **Background (Continued)**

#### **Individual Contributions**

We are inspired and grateful that individual members of our community have made up for the shortfall in 2020 revenues. Ongoing donations from April on have sustained us. Large donations in December 2020 and January 2021 (within the annual limit of \$5,000) have made us whole for the year. The larger donations are expected to be a one-time thing. And with no Jamboree in 2021 and group contributions expected to continue to be reduced in 2021, we will need ongoing individual support to make it through 2021.

#### **Other Fundraisers**

Texas law allows 501c3 non-profit corporations like CBIA to have only two fundraiser events. Traditionally, this has been the Jamboree and a second event like Septemberfest, Octoberfest or Founders Day.

In the absence of a Jamboree we plan to have one fundraiser event in the spring and one in the fall of 2021. These will be more like District 7's Unity Day in Port Lavaca and / or CBIA's Septemberfest last year with a hybrid combination of face-to-face and Zoom events.


#### What Has the CBIA Board of Trustees Done?

We determined that we had previously reduced expenses as far as possible without cutting services, and we did not want to do that. We have also decided that to ensure the future of the organization it would be unwise to cover the entire shortfall from our prudent reserve.

However, the board decided to move \$3,000 from Prudent Reserve (Savings) to Checking during the summer of 2020. The board also voted to reduce hours & payroll by 25% so Kelly (AM) and Rob (PM) will work three hours rather than four each work day. As of August 1<sup>st</sup> 2020, our hours are 8:30 – 11:30 AM and 2:00 – 5:00 PM Monday through Friday. The board also asked the Office Manager to ask the landlord about a smaller space / reduced rent. The landlord will let us know when a smaller space becomes available.

#### What Can a Group Do to Help?

The AA World Service pamphlet, <u>Self-Support: Where Money and Spirituality Mix</u>, <u>suggests</u> that AA Groups in areas served by an intergroup office distribute funds in excess of prudent reserve as shown below.



Thus, it is up to each group conscience to determine what (if anything) it gives to

#### What Can a Group Do to Help? (Continued)

Your group might want to re-consider its donation priorities temporarily. GSO and Intergroup have a bigger slice of the pie because they have much higher overhead (salaries, office space, etc.) than the other service entities. You might want to consider giving more to Intergroup and GSO and less to other service entities. Also, if your group has money earmarked that can be sent in earlier, that would be helpful.

#### What Can an Individual AA Member Do to Help?

As an expression of gratitude to AA for our sobriety, some of us give \$1 (or more) for each year of sobriety to CBIA in addition to or instead of the traditional birthday donation to GSO. To emphasize this, we will list members of the current year Birthday Club in our monthly newsletter in lieu of the monthly list of birthdays. (See Birthday Club in this issue.)

We are also adding a **Memorial List** immediately after the Birthday Club list. Any AA member can donate in memory of any AA member who has died in the current year. (See Memorial List in this issue.)

Individual member contributions in any amount (up to \$5,000 per year) are always gratefully accepted. To make donation easier, we now accept Venmo (CoastalBend-Intergroup), PayPal (under the Donate tab on our website www.cbiaa.org), and Major Credit Cards as well as Checks to CBIA, 3833 S Staples Suite S-212, Corpus Christi, TX 78411. Some members have been using the recurring donation feature in PayPal to have a fixed amount (\$5, \$10, \$20, etc.) automatically donated each month. This is particularly helpful.

## Helpline / 12 Step List

The Helpline is staffed by volunteers who make sure the hand of AA is available 24 hours a day by answering the intergroup phones overnight (5 PM to 8 AM) and on weekends (8 AM Saturday to 8 AM Sunday or 8 AM Sunday to 8 AM Monday). A minimum of six months sobriety is required to answer the phones. We need a few additional helpline volunteers at present.

If a caller needs help beyond meeting information, the helpline passes them to someone on the 12-Step List for a longer conversation on how to get sober and stay sober. A minimum of two years sobriety is required to be on the 12 Step List. We especially need people (particularly women) in the outlying areas.
