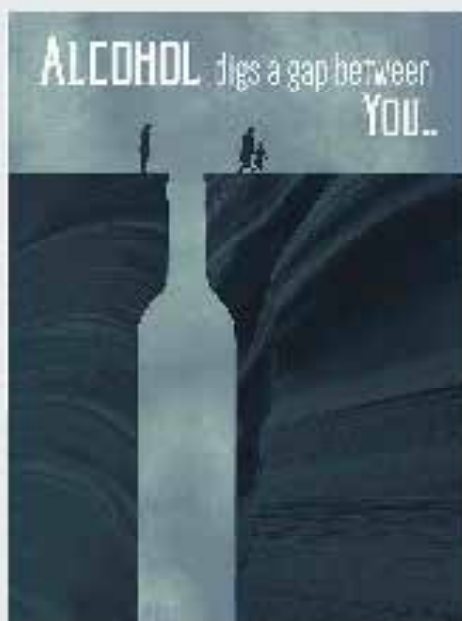

Step 2 - Hope

Step 2: Came to believe that a power greater than ourselves could restore us to sanity.

The principle behind Step 2 is HOPE. At the end of my drinking, I thought my best days were behind me. I was desperately trying to hold on in a last-ditch effort to slow down the rate at which my life was going down the tubes. Nothing I tried was working. Through my drinking, I'd gotten myself into a deep hole and I couldn't get out. I was utterly hopeless.

In my drinking days, **I had mistaken wishful thinking for HOPE.** Examples of my wishful thinking -

- I will have only two drinks;
- I will win the Power Ball Lottery;
- The Connecticut State Trooper will not notice that I am drunk.

Today, I think hope is about God doing for me what I cannot do for myself. *(Being able to say no to the first drink comes to mind.)* While I had never stopped believing in God, I didn't think HE believed in me. While I thought he could restore someone to sanity, I didn't think he would do that for me. Today, I believe that, with the Grace of God, the best is yet to come.

A phrase in Chapter 5, How It Works, in the Big Book changed my life: **"GOD COULD AND WOULD IF HE WERE SOUGHT."** That meant I just had to seek God. I did not have to go to THAT church or be like THOSE people. *(Been THERE, tried THAT, DO NOT WANT what they have.)* **I just have to seek God as best I can with the help of AA.**

The truth is when I started using alcohol to cope, when I started treating alcohol as THE ANSWER, there was no room for God in my life.

Step 2 - Hope *(Continued)*

When I was three months sober, I realized that **just before my first AA meeting I had cried out 'GOD HELP ME.' Help had come immediately.** I was in AA a few days later and I had my last drink a few weeks later. God had been there for me all along. It was I who had been unavailable to God. **I believe that the objective of all the work I've done in AA has been to make me available to the Grace of God.**

I thought being "restored to sanity" meant I would not have crazy thoughts anymore. I have been waiting 34 years for that to happen. Just before my 10th Anniversary a friend who ran a treatment center told me that if someone has a slip after 10 years they have only a 3% chance of achieving long term sobriety again. The first thought through my mind was "Perhaps I should drink now while the odds are better." Being restored to sanity, meant that the second thought was "Right, Robert, maybe you'd have a 4% chance of not destroying your life." Sometimes it seems like my mind thinks it can kill me and get away with it.

At its simplest: **in order for me to stay sober, I have to have enough sanity to not act on the insane thought that it would be a good idea to take the first drink --** in spite of a long history which has taught me that every time I started drinking again, it was a disaster. God has done that for me, on a daily basis, for 36 years.

I'm still crazy after all these years. AA is the only place where a crazy person can talk to another crazy person and we both get better. **Today, I try to be responsible for my craziness, so I don't hurt myself or other people like I used to.** Most of the time, I can recognize a crazy thought as a crazy thought and not be run by it. Sometimes, I can just identify a thought as questionable and I need another recovering alcoholic to help me see how crazy it is.

I found hope at my first AA meeting. Without hope, I would not have come back. It was hope that got me moving on my recovery journey and Step 2 introduced me to the profound truth that **GOD IS ALWAYS THE ANSWER.**

The New Phoenix Group

(The Foundation)

The New Phoenix Group was developed on April 29, 2004. The first building was located **at 2330 Airline Road.** The co-founders of the group were **Terry W., Rey R., and Peter B.** In addition to these three members, there were other contributors who shared their experience, strength, and hope. **David E.** was the artist who **designed the** logo for our **group flag.**

At the beginning, two meetings were held for the first month. In the third month, the 6:00 PM meeting was established. **Within the first year, New Phoenix became one of the biggest groups in Corpus Christi.** Attendance at the 6:00 PM and 8:00 PM meetings were ranging from 40 to 60 people.

In 2008, the New Phoenix Group moved to the Boardwalk to gain more parking space. While at the Boardwalk, the group has moved to three different rental spaces. Today we have **four meetings each day**, with the exception of **five meetings on Sunday.**

III. MINUTES:

- Minutes of the **November Board Meeting** were reviewed.
 - **Linda** moved to approve the minutes as read / as revised. **Barb** seconded. Motion carried.

IV. FINANCIAL REPORTS:

- **Linda** (*Financial Trustee*) presented the **November Financial Report**.
- **Balance Sheet:** Total CBIA funds as of **November 30th** totaled **\$18,672.56**; **\$50.00** in Petty Cash; **\$4,873.20** in Checking; **\$12,619.37** in Prudent Reserve and **\$1,129.99** in the Jamboree Account.
- **Profit & Loss** for the month of **November:** Group & Individual Contributions: **\$2,002.02**; Gross Sales (*Books, Chips & Medallions*): **\$495.50** less *Cost of Goods Sold* **\$308.78**; Gross Gain for the month was **\$2,188.74**; Total Expenses were **\$2,130.72** for a Net Gain of **\$58.02** for the month.
- **Linda** and **Rob** discussed where we are with our revenue shortfall in 2020.
 - **Net Revenue** through the end of **November** is **\$31,459.57** compared to Budget of **\$34,872.81** (*which was based on 2019 Actual Income*); Donations were **\$19,852.30** compared to Budget of **\$16,745.95**, Jamboree Revenue was **\$7,500.00** compared to Budget of **\$14,513.00**. Social Event Revenue was **\$1,901.00** compared to Budget of **\$997.00**; Social Event Expenses were **\$20.70** compared to budget of **\$1,100.00** (*church halls and DJ's were not rented*) and Net Sales (*after reduction for cost of goods sold*) were **\$2,124.95** compared to budget of **\$3,716.86**
 - Expenses were **\$30,944.85** compared to budget of **\$33,313.20** (*we have reduced hours and payroll by 25% beginning August 1st*)
 - Net Gain was **\$514.72** compared with a Budgeted Net Gain of **\$1,559.61**
- **Enrique** moved to approve the financial report. **Anita** seconded. Motion carried.

CBIA Needs Ongoing Support

Background

Jamboree

Historically, the Coastal Bend Jamboree has provided 40% of CBIA income for the year (about \$15,000).

In 2020, the Jamboree was small due to competition from the S Padre Island Jamboree and the SE Texas Area Convention in Houston which were held the same weekend for the first time. Revenue was about half of previous years. Future CB Jamborees will be held in February to avoid this problem.

Restrictions necessary to avoid having the Jamboree be a super-spreader event have made it not economically viable to have a Jamboree in 2021.

Group Contributions

In the past, CBIA's second biggest source of revenue has been Group Contributions. Since COVID-19 came to this area in March of 2020, **some groups are not meeting at all, others are meeting only on Zoom; and the remaining groups are having smaller face-to-face meetings. Hence, total Group Contributions**

Background (Continued)

Individual Contributions

We are inspired and grateful that individual members of our community have made up for the shortfall in 2020 revenues. Ongoing contributions from April on have sustained us. Large contributions in December 2020 and January 2021 (*within the annual limit of \$5,000*) have made us whole for the year. The larger contributions are expected to be a one-time thing. And with no Jamboree in 2021 and group contributions expected to continue to be reduced in 2021, **we will need ongoing individual support to make it through 2021.**

Other Fundraisers

Texas law allows 501c3 non-profit corporations like CBIA to have only two fundraiser events. Traditionally, this has been the Jamboree and a second event like Septemberfest, Octoberfest or Founders Day.

In the absence of a Jamboree we plan to have one fundraiser event in the spring and one in the fall of 2021. These will be more like District 7's Unity Day in Port Lavaca and / or CBIA's Septemberfest last year with a

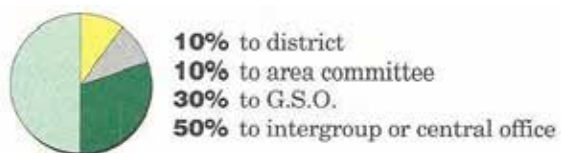
What Has the CBIA Board of Trustees Done?

We determined that we had previously reduced expenses as far as possible without cutting services, and we did not want to do that. We have also decided that to ensure the future of the organization it would be unwise to cover the entire shortfall from our prudent reserve.

However, the board decided to **move \$3,000 from Prudent Reserve (Savings) to Checking during the summer of 2020.** The board also voted to reduce hours & payroll by 25% so Kelly (AM) and Rob (PM) will work three hours rather than four each workday. As of August 1st, 2020, our hours are 8:30 – 11:30 AM and 2:00 – 5:00 PM Monday through Friday. The board also asked the Office Manager to ask the landlord about a smaller space / reduced rent. **The landlord will let us know when a smaller space becomes available.**

What Can a Group Do to Help?

The AA World Service pamphlet, **Self-Support: Where Money and Spirituality Mix, suggests** that AA Groups in areas served by an intergroup office distribute funds in excess of prudent reserve as shown below.



Thus, it is up to each group conscience to determine what (*if anything*) it contributes.

CBIA Needs Ongoing Support

What Can a Group Do to Help? (Continued)

Your group might want to re-consider its contribution priorities temporarily. GSO and Intergroup have a bigger slice of the pie because they have much higher overhead (*salaries, office space, etc.*) than the other service entities. You might want to consider giving more to Intergroup and GSO and less to other service entities. Also, if your group has money earmarked that can be sent in earlier, that would be helpful.

What Can an Individual AA Member Do to Help?

As an expression of gratitude to AA for our sobriety, some of us give \$1 (*or more*) for each year of sobriety to CBIA in addition to or instead of the traditional birthday contribution to GSO. To emphasize this, we will list members of the current year Birthday Club in our monthly newsletter in lieu of the monthly list of birthdays. (*See Birthday Club in this issue.*)

We are also adding a **Memorial List** immediately after the Birthday Club list. Any AA member can contribute in memory of any AA member who has died in the current year. (*See Memorial List in this issue.*)

Individual member contributions in any amount (*up to \$5,000 per year*) are always gratefully accepted. To make contribution easier, we now accept **Venmo** (*CoastalBend-Intergroup*), **PayPal** (*under the Donate tab on our website www.cbiaa.org*), and **Major Credit Cards** as well as **Checks** to CBIA, 3833 S Staples Suite S-212, Corpus Christi, TX 78411. **Some members have been using the recurring donation feature in PayPal to have a fixed amount (\$5, \$10, \$20, etc.) automatically donated each month. This is particularly helpful.**

The Helpline is staffed by volunteers who make sure the hand of AA is available 24 hours a day by answering the intergroup phones overnight (5 PM to 8 AM) and on weekends (8 AM Saturday to 8 AM Sunday or 8 AM Sunday to 8 AM Monday). A minimum of six months sobriety is required to answer the phones. We need a few additional helpline volunteers at present.
