The Spirit of Rotation

One of the most valuable resources of any organization is the experience of those who have gone before. The sharing of what they've done right, and the sharing of the mistakes they've made, become a solid foundation for continued healthy growth. Because of the wise and spiritual principle of rotation, we in Alcoholics Anonymous are blessed with a constantly vital and always growing pool of people whose primary aim is to serve the AA Fellowship. They are willing to share both success and failure in order to preserve what we have been given. How then can we continue to benefit from the experience of those who have rotated? My understanding of rotation has led me from one service job to another. I don't believe rotation means "I quit." I don't think rotation means "I've done my time, now it's someone else's turn." I do believe rotation means that "I have made my contribution in this capacity. Where can I be of use next?"

I feel a deep need to pass the message on. I have an obligation to the new person to pass on the message of recovery, but my obligation goes beyond today. It extends to those who will come through the doors of Alcoholics Anonymous fifty years from now, when I am dead and gone. Part of our message must be how to preserve this precious gift so that those yet to come will have the same chance at recovery and life we had.

From the beginning of AA, the concept of sponsorship has been one of our most important means of passing on experience. My early sponsors lovingly showed me simple and direct steps I could take that would produce very specific results. They demonstrated these results in their lives in such a way that I wanted what they had. I followed their suggestions and got the same results. I began to recover and walk the spiritual path as they did. How nice it was to have someone who had been over the path before to show me the rough spots and to explain the new things that were happening to me. When the time came, my sponsors shared with me about serving the Fellowship. I was to do for the new people what had been done for me. I was to make my time and my experience available.

One of the things I like best about spiritual people is that they are seldom rude. They don't often demand their own way, nor do they seem to be driven by a need to be right all the time. They do seem to be around and available, but usually wait to be asked. As I've gone from service assignment to service assignment, I've found that those who preceded me were always willing to share with me, but they also allowed me to make my own mistakes. They told me what they had done, what had worked and what had not. Often when I would go to my service sponsors, they listened, then said, "Let's see what the manual says" or "How does that idea fit the Concepts?"

A "loving invitation" always seems to work with me. So perhaps one

of the best ways for us to continue to benefit from our rotated servants would be to request that they put on a workshop at an assembly or be on a panel with others who share their experience. I once heard that the condition of "bleeding deaconism" was caused by service people who got

out of service.

I don't need a title, but I do need to be involved. I love the action of service. I love service people. I would be less if I couldn't participate. If this is so for me, then perhaps it is so for others. I need to ask them to continue to be part of my service life so that their precious learning is not lost. When I'm allowed to help plan a function, I try always to give out those "loving invitations." I need, and have, service sponsors. I call on the phone or stop by and visit. I don't always agree with my sponsors, but I always listen. But there will be nothing to listen to if I don't ask.

As is usually the case, the answer to most of my questions is in the question itself. "How can we continue to benefit from the experience of those who have rotated?" The best way I can think of to benefit from their

experience is to be certain that they are a part of *mine*.

Step 5 - Integrity

Step 5: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

This was hard for me because I had lived my life like appearances are everything. I was much more concerned with looking good that with doing good. Unfortunately, the greater my academic and professional accomplishments, the more impressive stuff I acquired, the louder my disease screamed "You are a phony." So I never really got the satisfaction or happiness I expected.

My greatest fear was that if you really knew what I was like and what I had done you would not like me and you would leave me and poor little Robby would be all alone living in the park at Christmas. So when I did my first fifth step with my sponsor, I half expected him to run screaming into the night. What I got was unconditional love. He told me about similar things he had done. I learned that **nothing human is unmentionable and nothing mentionable is unmanageable.**

Later I shared some of my deepest darkest secrets at a meeting. In the middle of it, people got up to get coffee and to go to the restroom. And I realized that **nobody but me was wrecked over this stuff**. I have learned that anything I am hiding from anybody takes a toll on me and anything I am hiding from everybody is eating me alive.

For me, the primary principle behind Step 5 is INTEGRITY: To thine own self be true. It is about holding me accountable for having my behavior be consistent with the sort of person I aspire to be, the sort of person God created me to be. INTEGRAL means the parts fit perfectly into the whole. I have become a full member of the human race, striving to fulfill the role God has in mind for me.

My lack of integrity most often showed up in what I did not say. Perhaps my ex- would not notice that we now have only 11 Waterford tumblers. If my parents or my teachers wanted to think that somebody else did it, who am I to tell them otherwise.

I used to get upset (*make that self-righteous anger*) thinking that somebody else was getting away with something. I have learned that in the end nobody gets away with anything, so the best course is always to take responsibility for what I did or did not do. Regardless of what other people think, I will know what I did and I will not be OK with myself, with God or with them until I own up to it.

When I was drinking, none of the physicians or mental health professionals I consulted were able to help me very much because I did not tell the truth about my drinking. One of the reasons I have usually chosen to do Step 5 with my sponsor is that I have a rule for myself "Don't ever withhold anything from your sponsor." A withhold is anything I do not want

him to know, usually because I think he will think less of me or because I am afraid, I won't be able to get away with doing something questionable that I want to do. So, before I hang up the phone or before I leave, I ask myself "What are you withholding?" Often, I've been thinking about doing something foolish -- perhaps something that will require amends; perhaps something self-destructive. Then I say, "And another thing I need to tell you . . ."

I think it is important for one person to know EVERYTHING about me. In early recovery, I went from person to person and from meeting, dropping a secret here and a secret there. That was better than hiding it from everybody, but it left me thinking "If anybody knew EVERYTHING, they wouldn't accept me."

From Step 5, I learned that I was not as good as I had hoped or as bad as I had feared. I was not the best little boy in the world and I was not the worst little boy in the world. I am, in a word, human. And that makes me part angelic child of God and part selfish and self-centered jerk.

Step 5 gave me a more realistic sense of my strengths and weaknesses which is necessary for me to have humility and be teachable. Taking Step 5 helped me identify patterns of bad behavior. While I never enjoy discovering these things (The truth will set you free, but first it will piss you off.), AA has given me the wherewithal to transform my rude awakenings into spiritual awakenings. There is great leverage in identifying my patterns: addressing one pattern can resolve a number of seemingly unrelated problems.

Having taken Step 5 is a deterrent to future bad behavior. Just thinking that I won't want to tell my sponsor about doing something, makes me think twice about doing it. I know that if I do it, sooner or later, I will tell Sponsor Dearest. So would it not be better to just not do it in the first place?

- Proposed Budget Revision for the Fiscal Year 2021: Group & Individual Contributions \$26,889.00, Jamboree Contributions \$0.00 (No Jamboree in 2021), Spring Fundraiser \$3,000.00, Fall Fundraiser: \$2,000.00, Gross Sales (Books, Chips & Medallions): \$6,996.00 (less Cost of Goods Sold \$4,782.00), Gross Gain for the year: \$34,103.00, Total Expenses: \$34,332 (vs \$36,543 due to payroll 30 hours/week at \$13/hour vs 40 hours/week at \$11/hour and rent escalation adjustment of \$1,019 vs \$828.
 - Ronnie moved to approve the Revision to the 2021 Budget. Michael seconded. Motion carried.

(Rent escalation is calculated by subtracting the base year (2005) operating expenses from last year's operating expenses and allocating the difference to tenants based on square footage.) - Rob requested board approval to instruct Value Bank to revise the signature card effective April 8th for the following accounts: Value Bank Checking Account No. 221218 and Prudent Reserve Savings Account No. 10181188As follows for each account add Rita Standish (incoming Office Manager)

- Rob said the Governor has rescinded the statewide mask mandate and occupancy restrictions leaving it up to individual businesses to set their own mask mandates and occupancy restrictions. Background

Jamboree

Historically, the Coastal Bend Jamboree has provided 40% of CBIA income for the year (about \$15,000).

In 2020, the Jamboree was small due to competition from the S Padre Island Jamboree and the SE Texas Area Convention in Houston which were held the same weekend for the first time. Revenue was about half of previous years.

Restrictions necessary to avoid having the Jamboree be a super-spreader event have made it not economically viable to have a Jamboree in 2021.

Group Contributions

In the past, CBIA's second biggest source of revenue has been Group Contributions. Since COVID-19 came to this area in March of 2020, some groups are starting to meet in person, others are still meeting only on Zoom; and the remaining groups are still not meeting. Total Group Contributions are starting to increase and we appreciate all the contributions being made so far this year.

Individual Contributions

We are inspired and grateful that individual members of our community have made up for the shortfall in 2020 revenues. Ongoing contributions from April on have sustained us. Large contributions in December 2020 and January 2021 (within the annual limit of \$5,000) have made us whole for the year. The larger contributions are expected to be a one-time thing. And with no Jamboree in 2021 and group contributions expected to continue to be reduced in 2021, we will need ongoing individual support to make it through 2021.

Fundraisers

Texas law allows 501c3 non-profit corporations like CBIA to have only two fundraiser events. Traditionally, this has been the Jamboree and a second event like Septemberfest, Octoberfest or Founders Day.

In place of Jamboree 2021, we have had one fundraiser event in April 2021 "The Hand of AA" event. It was held at South Shores Christian Church and was well attended in person and on Zoom, raising \$5707.00. CBIA's Septemberfest maybe a hybrid combination like last year with a combination of face-to-face and Zoom events, more details to follow soon.


What Has the CBIA Board of Trustees Done?

We determined that we had previously reduced expenses as far as possible without cutting services, and we did not want to do that. We have also decided that to ensure the future of the organization it would be unwise to cover the entire shortfall from our prudent reserve.

However, the board decided to **move** \$3,000 from Prudent Reserve (*Savings*) to Checking during the summer of 2020. The board also voted to reduce hours & payroll by 25% so Kelly (AM) and Rita (PM) will work three hours rather than four each workday. As of April 7th, 2021, our hours are 8:30-11:30 AM and 2:00-5:00 PM Monday through Friday. The board also asked the Office Manager to ask the landlord about a smaller space / reduced rent. The landlord will let us know when a smaller space becomes available.


What Can a Group Do to Help?

The AA World Service pamphlet, <u>Self-Support: Where Money and Spirituality Mix</u>, <u>suggests</u> that AA Groups in areas served by an intergroup office distribute funds in excess of prudent reserve as shown below.



Thus, it is up to each group conscience to determine what (if anything) it contributes.

Your group might want to re-consider its contribution priorities temporarily. GSO and Intergroup have a bigger slice of the pie because they have much higher overhead (*salaries*, *office space*, *etc.*) than the other service entities. You might want to consider giving more to Intergroup and GSO and less to other service entities. Also, if your group has money earmarked that can be sent in earlier, that would be helpful.



Birthday Club Members are people who have made an individual contribution to CBIA of \$1.00 or more for each year of sobriety during that calendar year. 

- 3. Maintains a 12 Step listing and calls individuals for 12 Step work.
- 4. Provides an A.A. listing in the Telephone directory.
- 5. Provides a 24 hour volunteer phone answering during hours when the office is closed.
- 6. Publishes meeting schedules of all groups in the Coastal Bend Area at no charge.
- 7. Publishes a monthly newsletter, the "Coastal Bender", to keep A.A. members informed of local A.A. affairs and special events.

- 10. Conducts Quarterly Meetings to keep groups apprised of Intergroup activities, and to seek group participation in CBIA affairs.
- 11. Maintains service committees for service work in the Coastal Bend Area.
