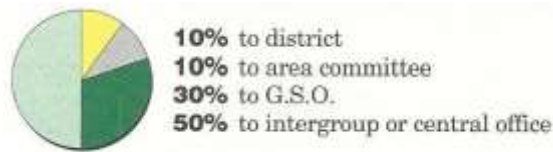


## CBIA Appreciates Ongoing Support
