## **December Birthday Month Story**

I am number 8 of 10 kids to a "good catholic family." I grew up next to a church and went to a catholic school. For 8 years was an altar boy and all that jazz. I always felt like I was different. I was scared of people and just didn't fit in, that was until I discovered alcohol. When I drank, I could ask the girls to dance, stand up for myself, and do things I normally wouldn't. I was kicked out of high school my junior year for skipping too much so I went to work. I lied about my age and started working for a heavy construction company. There I would work hard all day and reward myself with getting drunk afterwards. My motto was I work hard, play hard, and I will die hard! The first time I heard the word alcoholic I was going to the beach with my drinking buddy, it was 7:00AM. After a night of partying hard he stopped and asked if I thought we were alcoholics. I asked him what an alcoholic was and he responded it is someone who drinks too much. I paused for a minute and said "no". I then proceeded to grab the hose of the 8-gallon keg in the back seat and pour us a beer. That question stayed on my mind and I would ponder it often. My dad even told a lady in church that was looking for the AA meeting she could take me with her. She just smiled and said when he loses everything that means anything to him, he'll come around! That thought hit hard that I would have to lose everything before I quit drinking.

I had a brother that was much worse than me. I would always point my finger at him and say if I ever got that bad, I would quit drinking. Well, my brother ended up going to AA and got sober. He would come by and show me chips and he gave me a Big Book. I did not think he would stay sober but he did. I couldn't point my finger at him anymore and my drinking had gotten out of hand. I got to that point of desperation about 10 months later. I felt hopeless. I questioned why I was even born. The night of December 13th 1987 I asked God to help me. I felt an overwhelming presence of God in my bedroom that night and I knew I needed to call my brother and go to AA. He picked me up that Monday and took me to a 5:30 meeting at Humility house. I picked a poker chip and started my journey. I struggled at first with accepting I was an alcoholic. I was too young, I had a job, a family, and a house but I kept suiting up and showing up. Not taking a drink and coming to the realization I was definitely an alcoholic I slowly worked through the steps with my sponsor and my concept of God changed from one that was keeping score and going to punish me to a loving God that wants to help me. Today that relationship with my higher power is the most important thing in my life. I still get on my knees in the morning and make contact with him. I have a sponsor, I sponsor men, I have a service position, and I stay active in Alcoholics Anonymous. My life isn't perfect but I am truly blessed. I would not trade this life of sobriety for anything in the world.




# **CBIA Appreciates Ongoing Support**

More people are needed for "The Helpline". The Helpline is staffed by volunteers who make sure the hand of AA is available 24 hours a day by answering the intergroup phones overnight (5 PM to 8 AM) and on weekends (8 AM Saturday to 8 AM Sunday or 8 AM Sunday to 8 AM Monday). A minimum of nine months sobriety is required to answer the phones. If you are available to do this vital volunteer work, please contact CBIA as soon as possible to add your name.

If a caller needs help beyond meeting information, the helpline passes them to someone on the **12-Step List** for a longer conversation on how to get sober and stay sober. A minimum of two years sobriety is required to be on the 12 Step List. If interested please call Terry or Rita at the CBIA office (361) 992-8911 between 8:30-11:30 AM or 2-5 PM Monday thru Friday.
